- 9 DO NOT CHANGE RESIDENCE OR EMPLOYMENT WITHOUT FIRST NOTIFYING COMMUNITY CORRECTIONS/PROBATION OFFICER
- 10 SUBMIT TO SUBSTANCE ABUSE TEST WHEN ORDERED TO DO SO BY THE COMMUNITY CORRECTIONS/PROBATION OFFICER
CLIENTS WILL PAY ANY AND ALL COSTS OF TESTS. URINE TESTS ARE \$30.00. HAIR TESTS ARE \$80.00.
- 11 PAY THE SUPERVISION FEE OF \$40.00PER MONTH DURING THE SUPERVISION PERIOD, PURSUANT TO LOCAL ACT 04-544.
- 12 THE CLIENT IS ORDERED TO PAY ALL FINES, COSTS, RESTITUTION, ASSESSMENTS, AND OTHER COURT ORDERED MONIES PRIOR TO RELEASE OF ANY PROGRAM.

YOU ALSO MAY GO ONLINE AT ALLPAID.COM AND MAKE A PAYMENT. PLEASE BE AWARE A FEE IS ASSOCIATED WITH PAYING ONLINE. THIS IS FROM ALLPAID NOT COMMUNITY CORRECTIONS.
- 2 WHEN PAYING WITH CASH, YOU **MUST** HAVE CORRECT CHANGE. CHANGE WILL NOT BE PROVIDED.
- 3 IT IS YOUR RESPONSIBILITY TO PAY COURT COST, FINES, AND FEES PROMPTLY AS REQUIRED. IF YOU ARE 60 DAYS BEHIND IN PAYMENTS, WE MUST NOTIFY THE COURT OF NON-PAYMENT.
