WHEREAS, said voting precincts and voting places were last established and designated by the Morgan County Commission by resolutions adopted June 12, 2012, January 28, 2014, November 10, 2015, May 9, 2017, February 13, 2018, September 24, 2019, November 26, 2019 and,

WHEREAS, §17-6-6(b) and §17-6-4(d), <u>Code of Alabama</u> 1975, authorize the Morgan County Commission to make changes in said voting precincts and voting places; and,

**WHEREAS**, the Commission finds that, for the convenience of voters and to facilitate the election process, it is desirable to make certain changes in such voting precincts and voting places; and,

- Effective with the primary election scheduled for May 24, 2022, and for all federal, state and local (except municipal) elections conducted thereafter, the following voting centers are changed as follows, to-wit:
  - a. **Precinct 3-11,** move the voting center from Carrie Matthews Recreation Center to the Boys & Girls Club of Decatur, 1404 6th Street NW, Decatur, AL 35601 (the move is anticipated to be temporary)
