PUBLIC HEARING:

PUBLIC HEARING TO RECEIVE WRITTEN OR ORAL COMMENTS AND DISCUSS, VOTE UPON, AND TAKE ACTION AUTHORIZING AND APPROVE AN ALLOCATION OF UP TO \$100,000 OF THE AMERICAN RESCUE PLLAN ACT FUNDS TO DECATUR MORGAN COUTY TOURISM, INC. RESOLUTION FOR ALLOCATION OF AMERICAN RESCUE PLAN ACT FUNDS TO CARRY OUT ELIGIBLE PROJECT

WHEREAS, Morgan County, Alabama ("the County") has received American Rescue Plan Act state and local fiscal recovery funds ("ARPA funds") and is charged with ensuring that such funds are expended in accordance with state and federal law; and

WHEREAS, pursuant to 603(c)(3) of the ARPA, PL 117-2, March 11, 2021, 135 Stat 4, the County may transfer ARPA funds to eligible entities to carry out eligible ARPA funded projects; and

WHEREAS, the County may provide financial assistance to Decatur Morgan County Tourism, Inc., a private nonprofit entity, where this assistance will serve a public purpose that is an eligible use of ARPA funds; and

WHEREAS, Decatur Morgan County Tourism, Inc., has submitted a request for ARPA funding and project proposal; and

WHEREAS, County has considered and evaluated this entity's request for funding and project proposal and determined:

- 1) That the entity is eligible to receive ARPA funds,
- 2) That the entity has demonstrated that an award of ARPA funds to carry out the proposed project would serve a valid and sufficient public purpose, notwithstanding any incidental benefit accruing to a private entity; and
- 3) More specifically, that the entity will be of economic development to the community; and
- 4) That providing this benefit or service is within the County's state statutory or constitutional authority under Ala. Const. § 94.01.

WHEREAS, consistent with Ala. Const § 94.01, the County issued a public notice in the *Decatur Daily*;

WHEREAS, the Commission desires to enter into an agreement with Decatur Morgan County Tourism, Inc., to carry out the proposed project;

WHEREAS, the County will conduct a satisfactory risk assessment of Decatur Morgan County Tourism, Inc., and will develop a monitoring plan for the project; and

WHEREAS, the Commission has determined that the project is a necessary, eligible, and reasonable use of these funds.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1) The County hereby conditionally allocates up to \$100,000 of ARPA funds towards the purchase and/or renovation of a new visitor's center by and through a subaward to Decatur Morgan County Tourism, Inc.
- 2) The County hereby directs the County to perform a risk assessment of Decatur Morgan County Tourism, Inc. and develop a monitoring plan for this project; and
- 3) Conditioned upon (1) the completion of a satisfactory risk assessment and (2) the receipt by Decatur Morgan County Tourism, Inc. of a Unique Entity ID from SAM.gov, negotiate the terms and conditions of a subrecipient agreement with Decatur Morgan County Tourism, Inc., consistent with this Resolution.
- 4) The Chairman is hereby delegated the authority to enter into the subrecipient agreement if the agreement is consistent with this resolution and if, in his discretion, the terms and conditions are in the best interest of the County.
- 5) Upon the execution of a subrecipient agreement, Julie Reeves, Administrator, is hereby authorized to expend ARPA funds for costs of the project in accordance with the terms of this Resolution and the subaward agreement.
- 6) Expenditure of these funds, as authorized by this Resolution, shall be contingent on the continued appropriation and availability of ARPA funds for this purpose and in no event shall be used for any costs associated with the project that are not obligated on or before December 31, 2024, and expended on or before December 31, 2026.
