

ADOPT RESOLUTION AUTHORIZING THE COMMISSION TO EXPEND AMERICAN RESCUE PLAN ACT (ARPA) REVENUE REPLACEMENT FUNDS TO PROVIDE PAYROLL SUPPORT FOR IMPROVING LAW ENFORCEMENT SERVICES UP TO A MAXIMUM OF \$271,000.

Mr. Jeff Clark, member of the Commission, offered the following resolution and moved for its adoption. Upon the same being duly seconded by Mr. Randy Vest, it was put to a vote and unanimously adopted to wit:

RESOLUTION 24-473

RESOLUTION FOR THE EXPENDITURE OF AMERICAN RESCUE PLAN ACT FUNDS FOR GOVERNMENT SERVICES FOR ONGOING LAW ENFORCEMENT SUPPORT

WHEREAS, Morgan County, Alabama (the "County") has received American Rescue Plan Act fiscal recovery funds ("ARPA funds") and is charged with ensuring that such funds are expended in accordance with state and federal law; and

WHEREAS, in accordance with the provisions of Final Rule published by the United States Department of Treasury dated January 6, 2022, the County has duly elected to designate a standard allowance of up to \$10,000,000 of its ARPA funds as revenue replacement ("revenue replacement funds"); and

WHEREAS, the County may use revenue replacement funds to fund government services; and

WHEREAS, the Morgan County Commission ("Commission") has recognized a need to support the staffing in the Sheriff's Office to support ongoing law enforcement efforts in the County; and

WHEREAS, during the budget process for fiscal years 2023 and 2024, the Commission approved for ARPA revenue replacement funds to be utilized to cover funding for two new law enforcement positions and allocated up to \$271,000 of revenue replacement funds in ongoing support for payroll expenses; and

WHEREAS, the County has determined that utilizing ARPA revenue replacement funds to cover the cost of salary and benefits for all employees in the Sheriff's Office is a necessary, reasonable, and proportionate measure to facilitate the provision of these government services.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1) For the pay period ending September 21, 2024, the County shall use the balance of \$271,000 of ARPA funds which are hereby designated as revenue replacement funds, excluding the costs previously paid utilizing ARPA funds for the two new positions referenced above, to facilitate the provision of the government services described herein by covering payroll and benefits of all Sherrif's Office staff up to the not to exceed amount.
- On no less than a quarterly basis, the County Administrator will calculate the actual costs of salary and benefits and will reimburse the County General Fund accordingly.
- 3) The ARPA Program Director is charged with ensuring that revenue replacement funds allocated and expended to provide these government services will not be used in such a way as to frustrate COVID-19 mitigation guidance issued by the Centers for Disease Control, or for any other use prohibited by the Final Rule or any applicable state or federal law.
- 4) Expenditure of these funds, as authorized by this Resolution, shall be contingent on the continued appropriation and availability of ARPA Revenue Replacement funds for this purpose and in no event shall be used for any expenses not obligated by December 31, 2024, and expended by December 31, 2026.
