WHEREAS, Morgan County, Alabama (the "County") has received American Rescue Plan Act fiscal recovery funds ("ARPA funds") and is charged with ensuring that such funds are administered in accordance with state and federal law; and

WHEREAS, under the Final Rule published by the United States Department of Treasury ("Treasury") dated January 6, 2022, the County has the option either to elect a standard allowance of \$10,000,000 to be categorized as revenue replacement funds, or to perform calculations of revenue loss as provided in the Final Rule; and

**WHEREAS**, the Final Rule provides that the election is a one-time, irrevocable election that must be made for the period of performance of the ARPA funds award; and

**WHEREAS,** the election must be made in the next Project and Expenditure Report, which is due on January 31, 2022; and

WHEREAS, the Morgan County Commission (the "Commission") has determined that it would be appropriate to delegate the determination and election to its Chairman.

#### NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

The Chairman of the Commission is hereby authorized to elect a standard allowance of \$10,000,000 to be categorized as revenue replacement funds for the County and shall direct the County's authorized reporting representative for ARPA funds to make corresponding election in conjunction with the filing of the County's ARPA Project and Expenditure Report on or before January 31, 2022.
