Chapter 14 Section 14.09 MOTOR VEHICLE POLICY

Definition of Safety Review Committee: Committee consisting of Safety Director, EMA Director and HR Director.

Personal Vehicle Use: County employees are occasionally assigned to complete tasks on behalf of the County that will require the use of their personal vehicle. Mileage expense will be reimbursed if an employee uses his or her own personal vehicle for County business. To operate a personal vehicle on behalf of the County, you, as a County employee must comply with the following:

- You must comply with all federal, state, and local traffic, safety, and vehicular laws.
- You must possess a valid U.S. driver's license, and you must notify your supervisor immediately if your license is suspended or revoked.
- You may not operate a motor vehicle while under the influence of alcohol or any substance that impairs your ability to operate the motor vehicle safely. County employees are reminded of their continuing obligation to report the use of any medication, including prescription drugs or over-the-counter medication, that may affect their ability to work, including, but not limited to, operating a motor vehicle to complete tasks on behalf of the County.
- You may not use electronic communication devices while operating a motor vehicle. This prohibition shall not apply to law enforcement, emergency services, and public safety officials using such devices for emergency purposes in the line and scope of their duties.
- You must maintain appropriate automobile insurance and registration that is up to date and in good standing at all times.
- Any accidents or injuries must be reported immediately to your supervisor.

Employee Acknowledgement of Personal Vehicle Use

I understand that if I operate a personal vehicle to complete tasks on behalf of the County, then my automobile insurance will be responsible for any accidents. I represent that I maintain automobile insurance on my personal vehicle. I understand that the County will not be responsible for damage or loss to my personal vehicle or any property within my vehicle. I also understand that the County will not reimburse me or my automobile insurance company for any property damage or bodily injury sustained by any third party.
