NEW BUSINESS:

ADOPT RESOLUTION APPROVING SETTLEMENT WITH 3M AND SETTLEMENTS IN THE ST. JOHN AND TENNESSEE RIVERKEEPERS CASES.

Mr. Jeff Clark, member of the Commission, offered the following resolution and moved for its adoption. Upon the same being duly seconded by Mr. Randy Vest, it was put to a vote and unanimously adopted to wit:

RESOLUTION 22-046

WHEREAS, the Morgan County Commission finds and determines that it serves a public purpose, enhances the general health and welfare of our community, and is in the best interest of the County to approve three comprehensive separate settlement agreements regarding PFOS, PFAS, PFOA and related impacts on the environment; and

WHEREAS, the three settlements involve a separate settlement with the 3M Company and additional settlements in the pending cases of James St. John, et al. vs. 3M Company, et al., Case No. CV-2002-000408, in the Circuit Court of Morgan County, Alabama and Tennessee Riverkeeper, Inc. vs. 3M Company, et al., Case No. CV-16-HGD-1029-NE, in the United States District Court, Northern District of Alabama, Northeastern Division.; and

WHEREAS, the 3M settlement agreement provides that the County will receive a total of \$5,400,000.00; and

WHEREAS, as part of the overall 3M settlement payment not affecting the respective payment portions due each governmental entity, Morgan County, Decatur Utilities and the City of Decatur, do acknowledge and approve the payment of attorney fees in the amount of Seven Million Dollars to Harris, Caddell & Shanks PC, as the Law Firm that has represented those entities in the litigation and mediation from the beginning;

THEREFORE, BE IT RESOLVED by the Morgan County Commission that the Chairman and Harris Caddell & Shanks PC are hereby authorized to approve and execute on behalf of the County the three settlement agreement documents described above and being on file in the County Commission office; and in addition the Chairman is authorized on behalf of the County to take the necessary actions to assure the approved payment of the attorney fees described above.
